THE HOUSES ARE LOCATED NEAR LURIE CHILDREN'S HOSPITAL, UNIVERSITY OF CHICAGO COMER CHILDREN'S HOSPITAL, LOYOLA UNIVERSITY MEDICAL CENTER, ADVOCATE CHILDREN'S HOSPITAL AND CENTRAL DUPAGE HOSPITAL, THE FAMILY ROOMS ARE LOCATED INSIDE EDWARD HOSPITAL, LURIE CHILDREN'S AND UNIVERSITY OF CHICAGO COMER CHILDREN'S HOSPITAL. THE HOUSES ALLOW FAMILIES TO EAT, SLEEP AND FIND THE EMOTIONAL SUPPORT THEY NEED JUST BLOCKS FROM WHERE THEIR CHILD IS BEING TREATED. IN 2015 WE PROVIDED 41,638 FAMILY NIGHTS TO 5,805 FAMILIES, OFFERING THEM CARE AND COMFORT DURING THEIR HOURS OF GREATEST NEED.
